



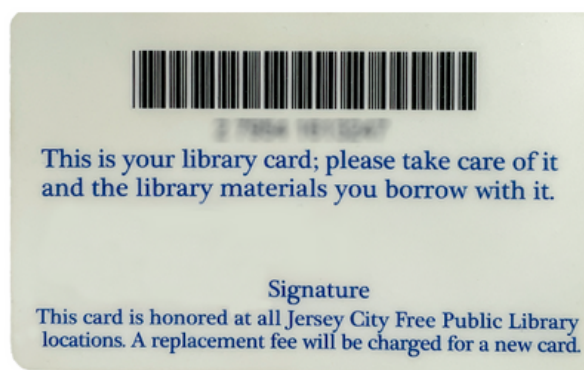
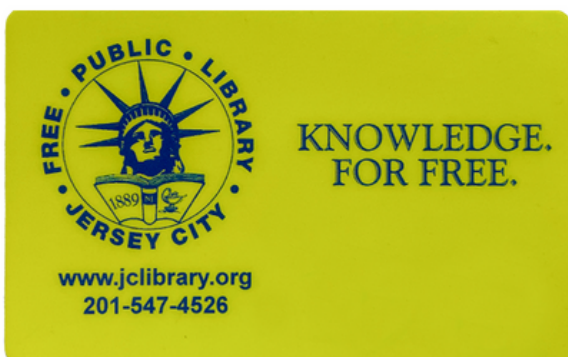

3. Proof of Address

An item that has the applicant's full name and residential address:

- Posted Mail with Name of Applicant
- First Class Mail from any Government Agency within the past 6 months
- Checking or Savings Account Statement from a bank or credit union issued within the last 60 days
- Mobile Phone Bill
- Utility or Credit Card Bill
- Lease Agreement
- Deed or Title to Physical Property
- Property Tax Receipt

Must be a separate item from the Photo ID.

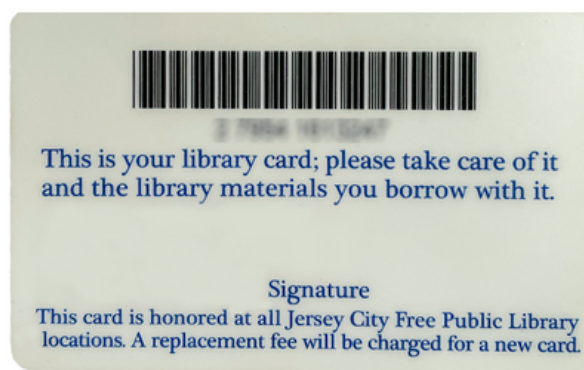
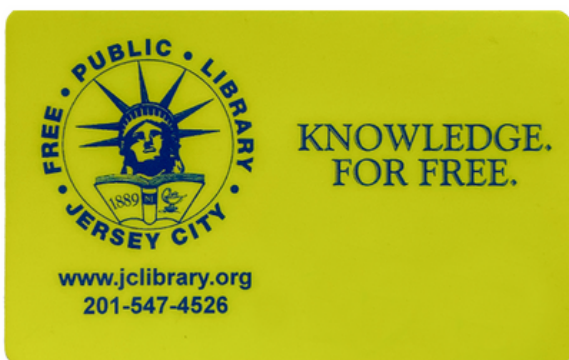
